

Newsletter 31 Tanya Plibersek (Minister of Health), Vaccines and Autism

On the 5th May, Tanya Plibersek (Australia's Minister of Health) stated in News Ltd press:

"The alleged link between autism and immunisation has been disproved. It is absolutely 100% not true".

Yet I can provide a list of hundreds of doctors, scientists and many parents that disagree with Minister Plibersek's claim. In addition, all parents should be asking how Minister Plibersek can make this claim when the government has not provided evidence from a controlled clinical study of vaccinated and unvaccinated cases – either in animals or in humans - that investigates the effects of the combined schedule of childhood vaccines. Are we to conclude that our children are the experiment?

Many of the ingredients of vaccines are known causes of allergies, anaphylaxis and autoimmune conditions. Please look at the Product Information for vaccines for evidence of this fact. This is why a family history of these conditions pre-disposes children to getting these neurological conditions and prior to 1990 they were considered a 'contraindication' for having some vaccines. That is, doctors recommended that some children shouldn't get particular vaccines due to their family history. However, after 1994 this medical knowledge was overlooked as the government recommended more vaccines be added to the schedule and given to children in schools. In this environment a family history of allergies and anaphylaxis is not discussed with parents. The government significantly increased the number of vaccines and the participation rates in vaccination programs during the nineties.

Over the nineties there was an explosion of children with allergies, anaphylaxis and autoimmune diseases (arthritis, diabetes, MS, autism): at great cost to our healthcare system and the quality of life of families.

Australia does not have a scheme to provide compensation to the children that get damaged by vaccines. The US compensation scheme has paid out over \$2 billion to children who have been damaged by vaccines - but they only compensate the ones that react within 4 hours of getting the vaccine. Did you know that many of the ingredients of vaccines have delayed reactions of months or years after the vaccine? Vaccine manufacturers in America are also not liable for any damage that is linked to a vaccine.

There is no scientific consensus on whether vaccines cause autism because the science to prove or disprove this link has not been done. However, there is abundant evidence to suggest vaccines may be causing this disease and many other diseases.

Please ask Minister Plibersek to provide the list of ingredients in the combined schedule of vaccines to ensure she is aware of what is being injected into infants. There is no case for recommending that all children get vaccinated with the government's schedule of vaccines until there is conclusive proof that vaccines are not causing autism and other chronic illness, and that vaccines are effective in preventing disease.
